



ALEC HOLIDAY SWEEPSTAKES – OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: ALEC Holiday Sweepstakes (the “Sweepstakes”) begins November 1, 2025 and ends December 31, 2025 (the “Sweepstakes Period”).

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who are age 18 years of age or older at the time of entry and are the primary cardholder in good standing with Abbott Laboratories Employee Credit Union (“ALEC”). Entrant must remain in good standing through the Sweepstakes Period and at the time of winner notification and verification. Directors, employees and their immediate family are prohibited from winning. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

HOW TO ENTER: There are two (2) ways to enter.

Method #1: Purchase Entry. During the Sweepstakes Period, for every purchase transaction using your eligible ALEC Visa® Credit Card, you will receive one (1) entry into the Sweepstakes for every purchase. Purchase Entries must post to the members account by January 1, 2026.

Method #2: Alternate Method of Entry (“AMOE”) / Mail-in Entry. To enter without making a purchase*, mail a postcard (the “Mail-In Entry”), including your name, complete address, email address, and phone number to the following address to receive one (1) entry into the Sweepstakes:

All methods of entry have an equal chance of winning.

PRIZES/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS. Odds of winning will depend upon the total number of eligible entries received.

Prize: There are four (4) \$500 cash prizes available to be won. The ARV of the Prize is: \$500.00.

RANDOM DRAWING: The prize winners will be selected in a random drawing on or around Friday, January 16, 2026 from among all eligible entries received during the Sweepstakes Period.

WINNER NOTIFICATION & VERIFICATION: Winners will be notified via email and/or phone. The prize will be awarded within approximately 45 days after the winner is verified. The \$500 Prize will be deposited into your ALEC savings account.
