**RIGHT TO KNOW ABOUT PERSONAL INFORMATION COLLECTED, DISCLOSED OR SOLD**

**Your Right** You have the right to request that We provide You with a list of Your personal information that We collect, use, disclose, and sell.

**Instructions** To obtain a list of Your personal information that We collect, use, disclose, and/or sell, You may:

## AUTHORIZED AGENT

### Your Right

You have the right to designate an authorized agent that may, on Your behalf, submit any of the requests described in this document to know, or to delete, or to opt-out of the sale of, Your personal information. To designate an authorized agent You must provide the authorized agent with written permission to act as Your agent. You must also provide the authorized agent with Your member number, so We can be sure that they are Your duly designated agent. You must also contact Us using any of the contact methods described above, and inform Us about the agent You have designated, so that We can be sure that the agent making requests on Your behalf has been duly authorized by You.
