**Other Fees & Disclosures:**Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are one or more days late in making a payment.

Balance Transfer Fee (Finance Charge):

2.00% of each balance transfer.

Cash Advance Fee (Finance Charge):

3.00% of the amount of each cash advance, however, the fee will never exceed \$50.00.

Returned Payment Fee:

\$24.00 or the amount of the required minimum payment, whichever is less.
